As of January 1996 the Oregon State Legislature passed a law that states, in part, *All food handlers employed in a restaurant, bed and breakfast, mobile unit, pushcart, commissary, or vending machine operation shall successfully complete a food handler training program and earn a certificate of program completion within 30 days after the date of hire.* "Food Handler" means any person involved in the preparation, manufacturing, or service of food in a restaurant, deli, or any other food service facility...this includes, but is not limited to, dishwashers, wait staff, and bus persons.

Food handler classes are given in English and Spanish as designated in the schedule above and are on a first-come, first-served basis. No pre-registration will be taken. We have booklets and tests available in Spanish, Korean, Vietnamese, and Chinese.

Plan to spend about 1½ - 2 hours at the training. Please bring your own pencil or pen. After you have passed the test, you may purchase a food handler card for \$10 (CASH ONLY PLEASE).
